**Name of Event:**

The Old Oaken Bucket and The Buckette Filly Division.

**Sponsor:**

The Delaware County Fair

**For:**

Foals of 2016. (Subject to USTA foaling date rules).

**To Be Raced As:**

Two races. An Open and Filly division for 3-year-old trotters.

**To Be Raced At:**

Delaware, Ohio, during Grand Circuit week in 2019.

**Nomination Fee:**

\$25 on May 15, 2017.

**Special Notice to Foreign Nominators:**

Nominators shall be active members of the USTA and the yearling must be properly identified to the satisfaction of the USTA at the time of nomination.

**Added Money:**

The Delaware County Fair will add \$12,000 to the Open event and \$8,000 to the Filly division.

**Starting Fee:**

Due by 10 a.m. three days before date of race. (Sundays counted)

**Estimated Purse:**

**Supplemental Payment:**

Two-year-olds not nominated in the May 15 yearling payment may be made eligible through a supplemental nomination fee of \$400 due on or before the March 15 payment. This supplemental payment is in addition to the normal March 15 payment.

**Filly Notice:**

Any filly may transfer to the Old Oaken Bucket for which she is eligible by paying an amount equal to the total required for colts and geldings plus the starting fee. Fillies may not declare or enter in both events.

**Transfer:**

Any horse or filly nominated to the Old Oaken Bucket or the Buckette can transfer to the Little Brown Jug or Jugette if a change in gait is made by making up the equal amount in payment. The same condition prevails for any horse or filly nominated to the Little Brown Jug or Jugette to transfer to the Old Oaken Bucket or Buckette.

**Racing Conditions:**

Each event to be raced in divisions at one mile each. The horse with the fastest time will receive the trophy. Purses will be divided equally by divisions and paid 50-25-12-8-5%.

**Notice:**

USTA Rule 11, Section 3 provides: "Failure to make any payment required by the conditions constitutes an automatic withdrawal from the event." The Delaware County Fair will construe payment to require that cash or check duly honored upon presentation to be received at the time specified in USTA Rule 12, Section 4. If a check is not duly honored upon presentation, the horse becomes ineligible to race, or if it races, to participate in the purse.

**Rules:**

This track is licensed by the State of Ohio Racing Commission and operates under the rules of The Ohio State Racing Commission in conjunction with The United States Trotting Association. The Delaware County Fair will have the final decision on all matters pertaining to the racing of these stakes.
