DUE DATE FOR ENTRIES & ALL PAYMENTS IS Sunday March 10th!!

Dear Owners & Trainers:

The stakes that your horse is eligible to with payments due March 10TH are listed on the enclosed RACE ENTRY FORM. Please circle the fee amount for the races you wish to enter, sign the form and return it to us with the appropriate fees so that it is received in our office no later than Sunday MARCH 10TH or sooner if possible.

This booklet describes the **CLOSERS** with payments due this month. If you wish to enter any of these races, please include it on your Race Entry Form where indicated. NOTE SOME CLOSERS are included on your race entry forms, some are not. *Please read this newsletter for all Closers.*

We would appreciate it if you would respond even if you are making **NO ENTRIES**.
Please return forms marked "0" or NO ENTRIES.

There are many payments due this month. Meeting the deadline of March 10th is extremely important. Please be considerate of the time it takes for us to process everyone's race entries by meeting the deadline. You may phone in any final changes through the morning of the 14th. No changes will be accepted after the 14th.

Please remember that our office **CAN NOT** advance stake fees. Please make whatever arrangements are necessary to cover your payments. All payments must be received and **Cleared by the 15th**. **Please make sure all Partners are aware that payments must be received prior to the 15th.**

Contact our office if you require assistance or need additional information. Please respond even if no entries are being made. PLEASE Reply early!

Any owner who has a **yearling** on file (**Foal of 2018**) will be sent a YEARLING NOMINATION LIST for initial stake nominations Mid April. If you have not yet listed a 2018 foal with us for nominations, now is the time to call. Be sure to register your foals with the USTA. **All** must be **registered** before May 15th. **YOU DO NOT WANT TO MISS YOUR YEARLING PAYMENTS.**

UPDATED RACE SCHEDULES

- Race Schedules for ALL horses will be updated and mailed out after the March 15th payments have been processed.

IMPORTANT NOTES:

- **Breeders Crown:** you must make the \$500 @ 3 payment to keep your horse eligible at 3.
- You can **STILL** make your 2 yr. old eligible to race in the Breeders Crown at 3 **ONLY** by making a *supplemental* payment of \$1500.00 due March 15th
- **Where there is an *asterisk* *** next to the payment line on your race entry; you must make this payment for *future eligibility* to this event.

REMINDERS

- Please include a copy of your race entry form or invoice with your check, so we can accurately match up checks received with the payments that are due.

- **To Avoid Discrepancies in Race Selections,** if you have partners and trainers receiving race entry forms, please coordinate so that we receive a response from ONE Partner only. **Thank you!**
